GUIDANCE NOTES FOR VISITORS TO THE GRANGE

Parking

Limited visitor parking is available during the daytime at the access area to The Grange, for people making short visits on Council business of up to 30 minutes. Ample free public car parking is available nearby for longer visits and location plans can be forwarded on request. On-site car parking is available for evening meetings after 5.00pm.

Access and Security

If you are visiting The Grange during normal office hours you should report to the main reception desk, where you will be asked to fill in a visitor's pass that must be worn at all times whilst you are in the building. Please remember to return your pass before you leave.

This will not apply if you come to an evening meeting: in this case you will enter via the rear access doors in the glass atrium at the back of the building and a Facilities Assistant will direct you to the room in which the meeting will take place.

Emergencies

In the event of a fire or any other emergency during the day, you will hear a continuous alarm. The designated officer or their deputy as set out in the displayed plans for each floor will take charge of any evacuation and try to ensure that no one is left within the areas for which they are responsible.

You should leave the building by the nearest available exit and go to the assembly point near to the exit barrier in the front car park. **Do not** use the lifts, and **do not** re-enter the building until someone advises that it is safe for you to do so.

If you discover a fire immediately operate the nearest fire alarm call point, inform reception or another member of staff, leave the building and go to the assembly point.

In the event of a fire or another emergency during an evening meeting, a member of staff will direct you to the nearest available exit.

First Aid

If someone feels unwell or needs first aid, please let a member of staff know.

Access for People with Disabilities

The Council Chamber and majority of Committee rooms are accessible to wheelchair users via the lift. There are specially adapted toilets on the ground floor (in main reception) and on the first floor of the building.

In the event of a fire or another emergency, wheelchair users will be guided to an area near to an exit to await the arrival of the emergency services.

Toilets

Public toilets are on the ground floor in the main reception area.

If you are visiting The Grange for an evening meeting, the toilets in close proximity to the Chamber and Committee rooms are all clearly signposted.

Smoking

The Council operates a NO SMOKING policy in all its office buildings, including the car park to The Grange.

1.0 Issue

1.1. Details of the revised political balance of the Council and the implications for the allocation of seats on Committees, Sub Committees and other Member Bodies.

2.0 Recommendations

2.1. Council is requested to:

- (i) consider the options detailed in Appendix 3 and 4 and other alternatives to achieve political proportionality in line with the Local Government and Housing Act 1989;
- (ii) allocate one additional seat on the Committees or Sub-Committee (if required for the implementation of the option detailed in Appendix 3).

3.0 Background

3.1. On 19 November 2024, the Council received a Notification of Constitution of a Political Group in accordance with the Local Government and Housing Act 1989. In addition, the Proper Officers also received a Requisition of Extraordinary Meeting of East Cambridgeshire District Council in accordance with the Council's Constitution (ref. Part A Page 3 Para 1.1.4) attached as Appendix 1.

3.2. The receipt of the notification of a new political group (Liberal Democrat & Independent Group) will have itself triggered a proportionality review and the need for the matter to be brought to Council. Nevertheless, the requisition notice has transcended this obligation.

3.3. The establishment of the Liberal Democrat & Independent Group has resulted in a revised political balance on the Council, specifically,

Conservative Group	14 Members
Liberal Democrat & Independent Group	14 Members

3.4. Therefore, there is a requirement to revisit the proportionality of Council as agreed previously (ref. Annual Council 23 May 2024 Agenda Item 4). The Council is obliged under the Local Government and Housing Act 1989 to allocate seats to

political groups and this distribution is based on the application of the principles detailed below (as far as reasonably practical).

- 3.5. The principles (ref. LGHA 1989 Part 1 (para 15 (5))) are set out below and should be considered in sequential order.
- (a) Not all seats on the body are allocated to the same political group.
 - (b) The majority of the seats on the body are allocated to a political group if they form the majority of the authority's membership.
 - (c) The number of seats on the ordinary committees of the Council allocated to a particular political group bears the same proportion to the total of all the seats on the ordinary committees of the Council as is the size of each political group.
 - (d) The number of seats on each individual body allocated to each political group bears the same proportion of the size of each political group.
- 3.6. The current allocation of seats on member bodies are detailed in Appendix 2. Please note that the proportionality calculations exclude the Licensing Committee and Licensing Statutory Sub Committee as advised by Counsel. In total, there are 53 seats on member bodies.
- 3.7. Returning to the principles outlined in paragraph 3.5
- (a) Clearly not all seats have been allocated to both previous political groups.
 - (b) There is no majority group as defined in the LGHA 1989 either in previous and new scenarios.
 - (c) Given that there are an odd number of total Committee places, the current 14/14 i.e. 50%/50% proportionality cannot be achieved. Appendix 3 proposes an alternative to meet proportionality as set out in this principle, its implementation is dependant on:
 - 1. Increasing one Committee/member body membership by one increasing total seats to 54 (please note that Planning Committee increase by one is provided for illustrative purposes only).
 - 2. Agreement between Group Leaders or Council on the ceding of places from the Conservative to Liberal Democrat & Independent Group.
 - (d) In the event of the principle in (c) above not being achieved, the alternative would be to increase seats on each eligible body by one to achieve an even allocation of seats on each member body. There would be no requirement to cede or gain. This option is detailed in Appendix 4.
- 3.8. The requisition notice as attached in Appendix 1 includes reference to electing Chairs/Vice Chairs to the Council's committees and sub-committees. The Monitoring Officer has taken Counsel's opinion on this specific matter and they have concluded that Chairs and Vice Chairs of committees cannot be changed during the municipal year (ref Part 4, page 15, para 24.1.2).

4.0 Arguments/Conclusions

- 4.1. The agreement of the option detailed in Appendix 3 and 4 (or any other alternatives which meet the legislative requirements for political proportionality) will require a majority vote of the Council. Any alternative proposal which does not meet political proportionality require a “nem con” vote.

5.2. Legal Implications
