The CCTV cameras shall continually record while the premises are open to the public and recording shall be kept

available and unedited for a minimum of 28 days with the date and time stamping. A staff member who

is conversant with the operation of the CCTV system shall be present on the premises when they are

open to the public and must be able to produce/download/ burn CCTV images upon reasonable & lawful

request by a police officer or an authorised officer of the licensing authority or, if not present, the conversant member of staff shall produce the footage as described within 48 hours of a reasonable & mp;

lawful request. Any footage must be in a format that can be played back on a standard personal computer or standard DVD player.

A fire risk assessment required under the Regulatory Reform (Fire Safety) Order 2005 (as amended) will

be completed and be available for inspection by an authorised officer. Valid public liability insurance

Combined fighting sports –defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts –are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
- a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
- a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
- a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.

- a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
- a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
- any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
- any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a
 travelling circus, provided that (a) it takes place within a moveable structure that
 accommodates the audience, and (b) that the travelling circus has not been located on the
 same site for more than 28 consecutive days.

We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.
