The project should provide digital inclusion initiatives to help improve people's digital skills so that they can use online services.</p> <p>The project will address the main challenges that people face to going online:</p> <ul style="list-style-type: none">• access - the ability to actually go online and connect to the internet• skills - to be able to use the internet• motivation - knowing the reasons why using the internet is a good thing• trust - a fear of crime or not knowing where to start to go online. <p>The delivery partner will remain SPS Training Solutions Limited, and a contract extension has been awarded via existing Contract Procedure Rules.</p>

	has been awarded by CPCA to continue the delivery of the project until 31st March 2026.
