Request:

Please could you provide:

- 1. The number of demolition permits issued by your council for each of the past five calendar years, September 2021 and September 2025.
- 2. If available, please include the following for each permit:
 - Address or location of the property;
 - Date the permit was issued;
 - Reason for demolition (if recorded);
 - Whether the building was classified as derelict, vacant, or structurally unsound before demolition.

Response:

In chronological order, beginning with the earliest, demolition notices lodged with East Cambs Building Control are as follows:

- 1.Outbuildings at 28 Forehill Ely acknowledged 26.01.2022 old derelict outbuildings
- 2.Vacant building and outbuilding at 20 Wellington Street Littleport acknowledged 27.04.2022 being demolished to make way for new housing on site.
