

Further to your information request FOI/EIR 25/26-358, please find your question and our response below.

Request:

25/03608/LIQ-02 Variation and Main Licence

I understand that the December and January 28 days limit has been applied to Vary to over 12 months and thus potentially 28 events over 12 months, is this correct?

I understand that it involves two key aspects amount amongst four proposed variations. But there appears to be very little information on your web site about the variation and the original main licence. There are no documents listed.

The first interesting comments about traffic through the village and the Fen Road, particularly in respect of extending the licence period to all year rather than December and January.

Not to mention noise issues experienced by residents on the northern side of the village and the Fen.

Can you please send me a copy of the all the key documents e.g. starting with the TMP and EMP for example.

12 months extension / variation is interesting because it raises the potential for all licence holder events to occur simultaneously and <u>Occur and Clash</u> with other licence holder, business, residents and village events adding to traffic issues.

Not to mention village events e.g. Weddings at the Church events at the Fassage Hall, the playground and the playing field (Cricket and Football etc) and the Lode Fate as just some examples.

So, there is the potential for two or three events occurring simultaneously causing traffic congestion issues in the village and on the Fen.

Have these considerations been taken into consideration with event clash all year?

Some more details about the examples of other Events:-

Anglesey Abbey now hold events during the day through the year see their web site. They also have use of overflow car parking in the village.

The Shed in Lode Road opens all year around,

The various Polo Sites on the Fen, particularly in the summer and they are located further down / onward on Fen Road.

Lode Fate in the summer

Church Weddings all year

Football and Cricket Matches all year

Fassage Hall events all year

In particular the summer the polo fields on the Fen are located to the north of the applicants site, and they hold various events during the year, using the Fen Road which is in a poor state of repair and narrow. They need safe access past the applicants site.

Not to mention maintaining, clear, safe access to all the Village and the Fen for the emergency services (Public Safety)
