Response:

- 1.We are currently using ezytreev tree management software.
- 2.Currently at 5,165 trees/tree groups, however we are only approximately 50% through updating and adding our trees to the new ezytreev database. Some of the trees transferred from our old management system do not have any data aside from species and location. Many sites have not yet been plotted on ezytreev.

We manage 128 TPO trees, however this is not a representative number as some of our TPO trees are woodlands (e.g Bloomsfield, Burwell), so the actual number of TPO trees under our management will be much higher.

3.Please see attached to this email our tree data from June 2022 onwards in XLSX form. As we only started using Ezytreev in June 2022 we cannot produce any electronic records prior to this. Our survey data does not include growth direction measurements. Ezytreev is only able to produce the most recent survey data and not multiple visits.
