Next Steps

If we believe that your project might qualify for a grant based on your EOI form, we will let you know as soon as possible. We will then likely ask your permission to make a visit to you, to inspect the building or other land that you intend to spend the funding on. That visit will enable a high-level check to see whether we think the project is likely deliverable and likely to achieve meaningful emission savings. At or after the visit, we may offer suggested amendments or alternatives, if we think they might deliver a better outcome. However, we will not be offering a full technical survey.

If we approve your expression of interest (as submitted or amended), we will send you the full application form so that you can set out more details and costings to us. We will then determine whether you qualify for a grant.
