Response:

East Cambridgeshire District Council confirms that we do hold the information requested, but has taken guidance from the ICO decision notice (<u>Microsoft Word - DN for website (ico.org.uk)</u> and we longer provide Business Rates information.

Section 41(1)(a) of the Act provides that information is exempt if it was obtained by the public authority from any other person (or company, local authority or any other legal entity) and disclosure of the information to the public by the public authority holding it, would constitute a breach of confidence. The information was provided to the Council from the Valuation Office and from the ratepayer themselves, and we consider that this information is provided in confidence. It is our view that disclosure of this information would constitute an actionable breach of confidence and so disclosure would also be unlawful under the Act. Section 41 of the Freedom of Information Act confers an absolute exemption on disclosure and there is no public interest test to apply.
